**NOTICE OF LICENSE PLATE SUSPENSION
FOR FAILURE TO COMPLY WITH MANDATORY VEHICLE INSURANCE LAWS**

IF YOU WERE NOT INSURED on the conviction date and this is your first suspension: your license plates will be suspended until you purchase the minimum liability insurance policy and the reinstatement fee of \$100 is received. This can all be done through your insurance agent or once you have obtained liability insurance you may pay the \$100 reinstatement fee online at WWW.ILIVS.COM along with the reference number at the top of the reverse side of this letter.

1. If this is your second Mandatory Insurance suspension, you must serve the 4 month mandatory suspension and pay the \$100 fee. You may go online at WWW.ILIVS.COM to pay your \$100 reinstatement fee after purchasing liability insurance, but you must serve the 4 month suspension. The earliest eligible date the registration suspension can end is printed on the front of this notice.
2. If the reason for the suspension is by a 'COURT CONVICTION" and the convicted driver is also the owner of the vehicle, this suspension can be cancelled only by an order of the court that submitted the conviction notice.
3. If you are driving somebody else's vehicle and they do not have liability insurance on the vehicle, the driver and owner of the vehicle may receive a suspension notice.
4. If this vehicle is Registered and Operated on Illinois roadways, then you must obtain liability insurance. If this vehicle has been **SOLD** or **REGISTERED OUT OF STATE** and your license plates are no longer used, or if you do not wish to obtain liability insurance, then you may surrender your license plates at any Secretary of State's License facility.
5. If your vehicle license plates are no longer in your possession and are still registered to you, then you may revoke your registration: to revoke registration, you will need to complete a **VEHICLE LICENSE PLATE REVOCATION FORM** and mail the form to the listed address so that the Secretary's Office may complete the revocation. The revocation request form may be found on the Secretary of State's website WWW.CYBERDRIVEILLINOIS.COM and in the search bar, enter VSD851.
