REQUEST FOR INSURANCE VERIFICATION

The Illinois Secretary of State has implemented the Illinois Insurance Verification System (**ILIVS**) in order to verify automobile liability insurance for vehicles registered in Illinois. **ILIVS** was unable to verify the insurance information for the vehicle below.

Our records indicate that this may not be your first violation of Section 7-601 of the Illinois Vehicle Code within the past four years. If you did not have an insurance policy for the above vehicle, you may be required to serve a four-month suspension of registration and pay a \$100 fee to clear the suspension. Section 7-601 of the Illinois Vehicle Code requires that you maintain liability insurance on vehicles registered and operated in Illinois (625ILCS 5/7-601). In order to prevent the suspension of your vehicle registration, you must take one of the following actions by the **Suspension Date**.

1. If this vehicle did have **LIABILITY INSURANCE** on the **Verification Date**, you must provide this letter to your insurance company or agent. Your insurance company or agent must electronically transmit your insurance information to **ILIVS** using the www.ILIVS.com website and the reference number at the top of this letter.
2. If this vehicle **DID NOT HAVE LIABILITY INSURANCE** on the **Verification Date** of this letter, you must obtain liability insurance and provide the information of this letter to your new insurance company or agent. You will be required to pay the Secretary of State a \$100 reinstatement fee to remove the suspension off your vehicle registration. Your insurance company or agent must also electronically transmit your insurance information to **ILIVS** using the www.ILIVS.com website and the reference number at the top of this letter prior to removing the suspension.
3. If the vehicle is not being driven on Illinois roadways (STORED OR INOPERABLE), you must log into www.ILIVS.com with this letter and follow the directions. You will be required to fill out an electronic affidavit along with your electronic signature. You must notify your insurance company or the Secretary of State prior to driving this vehicle on Illinois roadways.
4. If this vehicle is operated on Illinois roadways, then you must obtain liability insurance. If this vehicle has been SOLD and your license plates are no longer being used or if you do not wish to obtain liability insurance, then you may surrender your license plate at any Secretary of State Driver Services facility.
5. If your vehicle license plates are no longer in your possession and are still registered to you, then you may **revoke** your registration. To revoke the registration, you will need to complete a **VEHICLE LICENSE PLATE REVOCATION REQUEST FORM** and mail the form to the listed address so that our office may complete the revocation. The revocation request form may be found on the Secretary of State's website at www.cyberdriveillinois.com (enter "VSD851" in the search bar).

WARNING

Your vehicle cannot be driven by anyone while its license plates are suspended. The minimum fine for driving a suspended vehicle is \$1,000.
